- 1. Q. This shouldn't take very long at all. If you don't mind, I'm going to I'm going to put you on speaker, but there's nobody else around, just so I can have it hands-free moving around with my papers, I want to make sure I get everything right here.
- A. That's okay. I'm actually, I am driving, I'm on my way to Providence, I have a meeting, so ...
- 2. **Q**. Okay.
- A. -- and if I have -- if we're not done in like 20 minutes, then I can just give you a call back when ...
- 3. Q. Yup. Yeah, that's fine. I can probably almost assure you we'll be done in twenty minutes.

  - A. Yes.

  - A. I was assigned to Health, Education and Welfare, ...

  - A. -- and I was assigned to the Small

- **9. Q.** Okay.
  - A. And and I was assigned to House Oversight.
- **10.** Q. Okay. And probably in that order?
  - A. Yes.
- 11. Q. Okay. So House I mean, 'm sorry, Health, Education and Welfare timeframe, like 2006 to?
- A. No. No, I was sworn in in two thousand January 2007, and I've been 2007 until two thousand um Let, let me think for a second, because I led I left in mid-session ...

- A. So I served on H.E.W. until I began serving on House Oversight, which was my last two years I was on House Oversight.

when you're in the General Assembly, there are legislators who, you know, want their names to be on a bill because they want to get credit for things, ...
