- 3. Q. Are you are you presently with the House, or or no?
  - A. I am, yeah.
- **4. Q.** You are. Okay. Can you just give me a little timeframe on on when you came into the House, and obviously you're present right now.
- A. ... I came in in two thousand in 2009 I won my election, so It was actually a special election because my father had passed away unfortunately.
- **5. Q.** Oh, I'm sorry to hear that.
- A. Yeah. And um, so they had So like and I ran and I Yeah, it was like kind of in the middle of the term.
- **6.** Q. O Okay. And, and what, what is your what area do you represent?

A. I represent the west end of Providence, which is over by the Armory, I represent Reservoir Triangle and also Elmwood area, like where Roger Williams Park is.

- 7. Q. Okay. Okay, and so so you were obviously in the in the House during 2010.
  - A. Yup.
- **8. Q.** Did you have the opportunity to participate in any debate regarding the Jobs Creation Guaranty Program?
- A. Well I was there and I had the opportunity; I was on the floor the day that it came up for a vote. But I didn't really participate in any debate.
- **9. Q.** Okay.
  - A. It was kind of my first year up there, so ...
- 10. Q. Okav.
  - A. -- it was relatively, a lot of stuff was relatively new for me, so.
- 11. Q. O Okay. Were you were you assigned to any committees?
- A. I was. At the time I was assigned to HEW, Health Education and Welfare

  Committee. And So yeah, that was my first assignment. After that, after that year, later on I got assigned to Finance, but not that year, you know.
- **12. Q.** Right. Okay. All right. So there there would have been no reason for this particular bill to come through that committee I would imagine.
- A. No, no, there wasn't. So we never had That was in the Finance Committee where they where they took that up.
- **13. Q.** Right.
- A. And then when it came to the floor, to be honest with you, at the time it was pitched as a jobs program, ...

- **14. Q.** Mm hmm.
- A. -- and something to help out a lot of the companies because they had trouble accessing capital in Rhode Island ...
- 15. Q. Okay.
- A. And nothing really stuck out to me, and maybe it should have, you know, that we increased it by 75 million. But um, as I said, I was relatively new up there and, you know, I was kind of following following the lead of the leadership, you know.
- **16. Q.** Okay. All right, so so prior to this coming to the floor for its for the vote, were you involved in any conversations or whether it be on the floor or even in the hallways or even at like, social events, at restaurants or wherever it may be at, at ... at homes regarding this bill and / or the possibility of 38 Studios coming to Rhode Island?
- A. No. No one ever really mentioned it to me, you know, about 38 Studios or anything after that After the fact, you know, I was aware of 38 Studios, so, when they came and when they had the press conference and different things like that and for the city that they were going to be located in the city. But I didn't know this program was specifically for them, you know.
- **17. Q.** Right.
- A. And I never really never really asked, I kind of, kind of followed You know, I got support from the leadership and I kind of followed their lead on on the stuff, and once things came to the House floor, usually usually they pass, you know.
- **18. Q.** Were you O, okay. So did you know who 38 Studios was prior to it coming to the floor?
  - A. No, I didn't.
- 19. Q. Okay. All right. And when you say you follow the leadership, what do you mean by that,

you just watched the way they voted and you voted, or was it some ...?

- A. No, not not necessarily. But most of the things that came to the floor, usually they were vetted in the committee process and uh um, most of the time, you know, we'd follow the committee's recommendation. Because that's where mostly legislation gets If the hearing gets testimony as far as whether it's a good or bad bill. So at the time, you know, I followed the committee process and, and uh, now being up there a little longer, you know, I feel a little more comfortable to do some more research on my own, you know.
- 20. Q. Mm hmm. Okay, so ...
  - A. But ...
- 21. Q. So the the committee, after they hear the bill and they do their debate in committee, like is it am I correct in assuming that the committee now comes to the floor, or whether it be the chair ...
- A. Yeah, yeah. So So usually there's a vote in the committee and it's you know, the vote, and you get a recommendation from the committee, the committee recommends passage of whatever the bill might be. And usually if it's overwhelming in the committee process, you kind of uh, kind of go off their recommendation, you know.
- 22. Q. Okay, so did anybody approach you independently of that, you know, ...
  - A. No, no one did.
- **23. Q.** Okay.
  - A. No one [Indiscernible] independently.
- 24. Q. Okay. Do you know who Michael Corso is?
- A. Um, I do know him, but I don't know him I just know him from seeing him in the city because I, you know, I work for the city and I work downtown. But I never had any

- 25. Q. Okay. In what what capacity do you work for the city?
  - A. I'm a budget analyst. I'm an accountant for the City of Providence.
- 26. Q. Okay. And how long have you been employed there?
  - A. Twenty years.
- 27. Q. Okay. That's quite some quite some time. All right.
  - A. Yeah.
- **28.** Q. So so you you met or you came to know Michael Corso through your deal- his dealings at City Hall?
- A. No, not necessarily. Just from I'd be walking I used to go get coffee over at Tazza, the restaurant over there, and I got to know him through there.
- **29.** Q. Okay. And and how long, I mean if you had to kind of estimate, how how long you've known him personally?
  - A. Maybe like six years or so?

  - A. But not not to any like, degree where outside of a hello and, you know.
- **31. Q.** All right. And was was he aware that you were a House representative during, you know, your early years, two thousand ...
  - A. Oh yeah. Yeah.
